

Process at HV inspection site: Information for site hosts

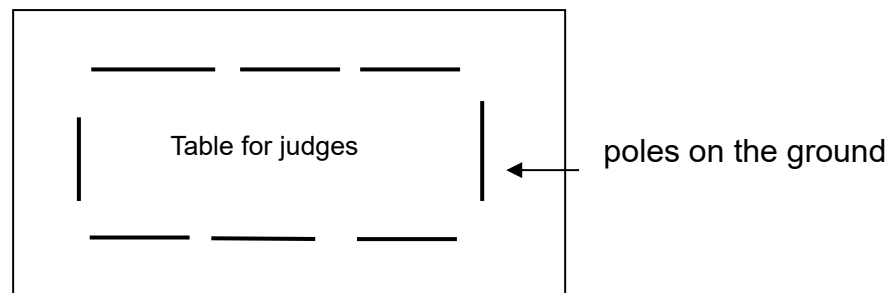
The site host is responsible for fulfilling the requirements specified below.

Registration office

- You as the host receive a list with the entered horses with their head number and / or the foal catalog.
- After arriving at the site, breeders should report to the registration office. The person in the registration office is responsible for creating a starting order.
- The inspection always begins with the stallion licensing, followed by the mare approval and the foal registration.

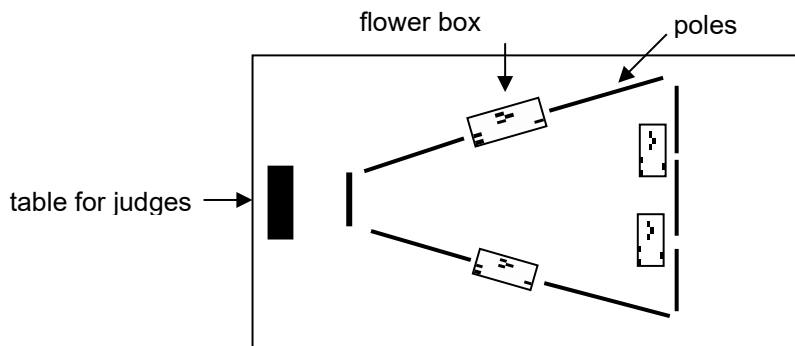
I. Arena for the mare approval (needs to be fenced in or indoor):

- 3m wide outer track with colorful poles
- One person for whip assistance
- Table in the middle for judges
- Place for the spectators (standing or seated)



II. Arena for foal presentation (preferably fenced in):

- Mark the triangle with poles and / or flower boxes on the ground
- One person for whip assistance
- Table for judges
- One pole approx. 2-3 m in front of the table for the judges



III. Measuring the mares and registering the foals

- Quiet place on flat, clean, level ground, possibly in wide stable aisle or wash box
- Small table for our documents
- **Measuring stick must be available (!)**

VI. Procedure of mare approval and foal registration / branding

It always starts with the presentation of the mares, then the foals are presented and judged. If a mare with foal has to be approved, the foal evaluation can also take place immediately afterwards. Yearlings and older horses come last.

A. Mare approval without foal registration:

- Submission of horse passport and measuring of the mares in the stable aisle
- Presentation for approval in the indoor arena
- Give passport and measuring paper to the judges, documents stay with the commission
- Presentation of the mare according to the judges' instructions
- End of approval
- A final ring takes place depending on the number of premium mares and the evaluation of the judges

B. Mare approval with foal registration:

- Mare approval: please see above
 - Foal registration: After completion of the mare approval, the foal is presented at foot for evaluation either in the indoor or outdoor arena
 - Registration card is handed over to judges
 - Evaluation of the foal
 - Afterwards checking of the microchip number
 - Checking of the color and markings on the registration card
 - Optional branding with the Holsteiner brand
- If branding is wanted at your inspection site, please provide a torch or oven for heating the iron**
- The passport for the foal comes by mail if all payments (membership, registration and inspection fees) are paid

C. Foal registration (if dam is already approved):

- Presentation of the foal for evaluation in the arena
 - Registration card is handed over to judges
 - Evaluation of the foal
 - A final ring takes place depending on the number of premium foals and the evaluation of the judges
 - Afterwards checking of the microchip number
 - Checking of the color and markings on the registration card
 - Optional branding with the Holsteiner branding iron
- If branding is wanted at your inspection site, please provide a torch or oven for heating the iron**
- The passport for the foal comes by mail if all payments (membership, registration and inspection fees) are paid
