In addition, a good faith effort to recover the original Certificate of Registration/Certificate of Pedigree from the previous owner must be made by the seller and/or the new owner.

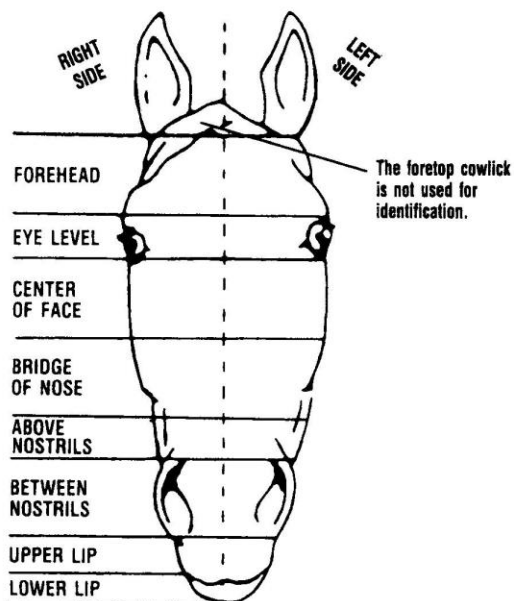

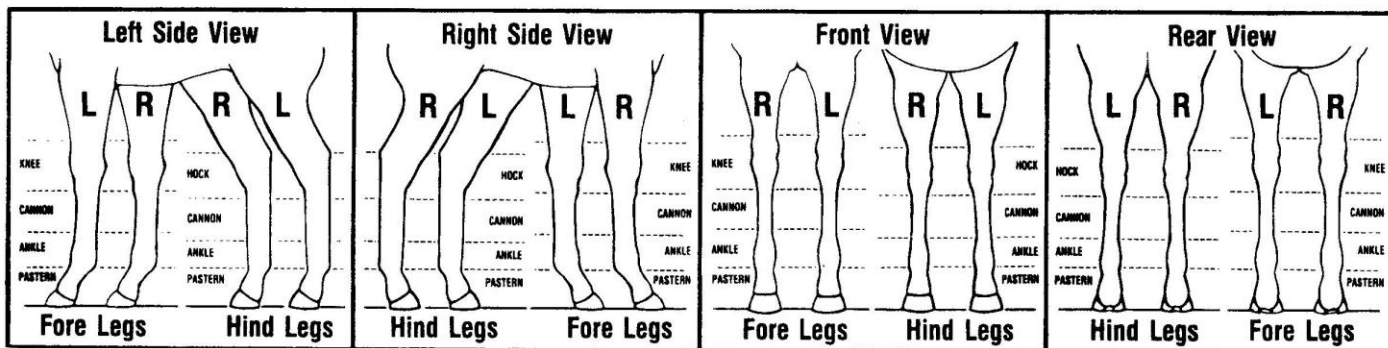
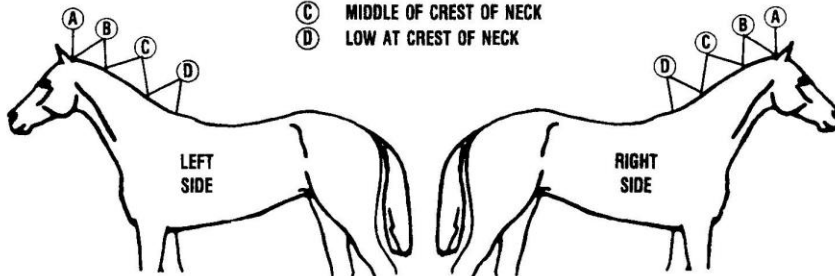
